

Customs and Excise (Suspension) (Amendment) Regulations,  
2015 (No. 138)

---

IT is hereby notified that the Minister of Finance and Economic Development, in terms of section 235 as read with section 120 of the Customs and Excise Act [Chapter 23:02], has made the following regulations:—

1. These regulations may be cited as the Customs and Excise (Suspension) (Amendment) Regulations, 2015 (No. 138).

2. The Customs and Excise (Suspension) Regulations, 2003, published in Statutory Instrument 257 of 2003 (hereinafter called “the principal regulations”), are amended—

- (a) in section 9K (“Suspension of duty on specified motor vehicles imported by Safari Operators”) by the deletion of “31 December 2015” and the substitution of “31 December 2017”;
- (b) in section 9M (“Suspension of duty on wheat flour imported by approved importers”)—
  - (i) by the deletion of “31 December 2015” and the substitution of “31 December 2016”;
  - (ii) by the deletion of the table in the Schedule titled “Approved Wheat Flour Importers Eligible For Suspension of Duty” and the substitution of the following—
