Further Agreement

Amendment to the Principal Agreement

This further agreement is made and entered into in accordance with the provisions of the Labour Act [Chapter 28:01] between the Tobacco (Miscellaneous) Industry Employers' Association (hereinafter referred to as "the employers"), of the one part, and the Zimbabwe Tobacco Industrial Workers' Union (hereinafter referred to as "the employees" or "the trade union"), of the other part, being parties to the National Employment Council for the Tobacco Industry, to amend the Collective Bargaining Agreement (General Conditions of Employment) Tobacco (Miscellaneous) Industry,1993, published in Statutory Instrument 85 of 1993, as amended (hereinafter referred to as "the principal agreement") shall be read as one with the principal agreement.

Agreement

This further agreement shall be deemed to have come into effect on 1st October, 2019, and is applicable up to 31st December, 2019. Grade minimums have been agreed for the period and are reflected below. In addition, it has been agreed by the Employment Council that the basic wage of an employee is an all inclusive wage, inclusive of all allowances, i.e. housing and transport.
