# DUE DATE: 10 SEPTEMBER 2020

- 1) Pay As You Earn [PAYE]
- 2) Withholding Taxes/Royalties

## 3) Intermediate Money Transfer Tax (IMTT)

Zimbabwe Revenue Authority (ZIMRA) hereby reminds all its valued clients that the following returns and payments for the month of **August 2020** are due on the **10<sup>th</sup> of September 2020**:

### **RETURNS DUE**

- a) Employees' Tax or Pay As You Earn (PAYE) Remittances [P2 Remittance Advice Form]
- b) Withholding Taxes /Royalties Returns [REV5 Form]
- c) Intermediate Money Transfer Tax (IMTT) [REV5B Form]

### 1. HOW TO SUBMIT THE DUE RETURNS

- All PAYE Remittance Advices (P2 forms) should be completed in full and submitted through the ZIMRA e-services platform (<u>http://efiling.zimra.co.zw</u>).
- In cases where Form P2 has failed to submit online using ZIMRA e-services platform, scan and email the return to the relevant email address selected from the list below:
- ➡ For all Rev 5 Forms and Rev 5B forms, submission should be done via relevant emails addresses selected from the list provided below.

#### 2. PAYMENTS AND ARREARS DUE

Payments for all taxes should be remitted on time through banks. Refer to the following link on ZIMRA website for ZIMRA Bank Accounts details: <u>https://www.zimra.co.zw/profile/2037-zimra-bank-accounts</u>

All clients who are in arrears with regard to their tax payments are required to settle the outstanding amounts or to engage their nearest ZIMRA offices to discuss and agree on payment terms.

ZIMRA urges its valued clients to file their returns and pay taxes due on time and in full to avoid follow-ups.

**<u>NB</u>** Where transactions are in **foreign currency**, payment of taxes should also be in foreign currency.
