Preparation of Proposals:

Only consultants registered with the Procurement Regulatory Authority of Zimbabwe in terms of section 4 of the Regulations are eligible to participate.

You are requested to submit a Proposal to provide the consulting services detailed in the Statement of Requirements by submitting separate technical and financial proposals, as detailed below. The standard forms contained within this Request for Proposals may be retyped for completion but the Consultant is responsible for their accurate reproduction.

You are advised to read carefully the complete Request for Proposals document, including the Special Conditions of Contract in Part 3, as well as the Contract Agreement and the General Conditions of Contract for Consultancy Services (available on the Authority's website or on request), before preparing your proposal. Part 3: Contract Agreement is provided not for completion at this stage but to enable Consultants to note the Contract terms they will enter into if their bid is successful.

The pre-bid will allow bidders to get clarification on the scope of work to be done and the expectations of ZIMRA. Number of bids allowed

No Consultant or Firm may submit more than one bid, either individually or as a joint venture partner in another bid, except as a subcontractor. A conflict of interest will be deemed to arise if bids are received from more than one Consultancy owned, directly or indirectly, by the same person.

Basis of Pricing and Payment:

The contract will be a time based contract.

Payments will be made on the following basis:

The contract price must be a maximum amount. Payment will be made for the time actually spent and for reimbursable expenses actually incurred by the Consultant in the performance of the Services, using the rates specified in the Breakdown of Contract Price.

Payment shall therefore be made according to the following deliverables:

The minimum period for which the Consultant's proposal must remain valid is 60 Days from the deadline for submission of proposals.

Financial proposals of rejected bids will be returned unopened. Financial proposals for accepted bids will be opened in public on the date specified in the notice of results for the technical evaluation.

Withdrawal, amendment or modification of Proposals:

A Consultant may withdraw, substitute, or modify its Proposals after it has been submitted by sending a written notice, duly signed by an authorized representative. Evaluation of Proposals:

The evaluation of proposals will use the Quality and Cost Based Selection (QCBS) evaluation methodology as detailed below:

Quality and Cost Based Selection (QCBS):

- 1. Preliminary examination to confirm that all documents required have been provided, to confirm the eligibility of consultants and to confirm that the Consultant has accepted all terms and conditions without material deviation or reservation;
- 2. Technical evaluation to assess the technical quality of proposals against the criteria below, to determine the technical score for each proposal and to determine which proposals reach the minimum technical score given below; and
- Financial evaluation to determine the financial score of each proposal, to weight the
 technical and financial scores and to determine the total score of each proposal.
 Proposals failing any stage will be eliminated and not considered in subsequent stages.

Technical Evaluation Criteria:

Submitted proposals shall be evaluated and awarded by using the technically qualified with lowest price approach. Technical proposal shall be evaluated out of 70% whereas Financial shall be evaluated out of 30%.

Financial Criteria:

Financial scores will be determined by awarding 100 points to the lowest priced proposal and giving all other proposals a score which is proportionate to this.

Total scores will be determined using a weighting of 70% for technical proposals and a weighting of 30% for financial proposals."

Currency:

Bids should be priced in both United States Dollars (US\$) and Zimbabwean Dollars (ZW\$). The payment will be made in Zimbabwean Dollars, using the prevailing exchange rates published by the Reserve Bank of Zimbabwe (RBZ). The US\$ price shall be used as the bases for any future price increases in the event of RBZ rate movement.

Recommendation for Award:

The proposal with the highest total score will be recommended for award of contract, subject to any negotiations required.

Award of contract:

Award of contract will be by placement of a contract in accordance with Part 3 of this Request for Proposals. The proposed award of contract will be by issue of a Notification of Contract Award in terms of section 55 of the Act which will be effective until signature of the contract documents in accordance with Part 3: Contract. Unsuccessful Consultants will receive the Notification of Contract Award and, if they consider they have suffered prejudice from the process, they may, within 14 days of receiving this Notification, submit to the Procuring Entity a Challenge in terms of section 73 of the Act, subject to payment of the applicable fee set out in section 44 of and the Third Schedule to the Regulations.

The contract will only be valid subject to payment of annual contract administration fees in line with Part V of the Fifth Schedule to the Regulations.

The Zimbabwe Revenue Authority would like to hire the services of a qualified consultant to undertake the recruitment and selection process for the positions of Commissioner General and Director Finance & Administration.

1. Objectives

- i. To assist in the shortlisting of received applications.
- ii. Present a Shortlisting Report to the Chairman of the Human Resources Committee copied to the Director Human Capital
- iii. Ensure candidates undergo psychometric tests by a qualified and registered Psychologist. This process to proceed once the HR Committee approves the shortlisting report.
- iv. Design an interview framework based the job profile
- v. Share the interview framework with the interview panel only on the day of the interview for adoption and incorporate any amendments suggested by the Panel.
- vi. Provide secretarial services to the interview panel
- vii. Prepare an interview report and share the same with the Chairman for the Human Resources Committee.

2. Duties and Responsibilities

- i. Receive all applications from Director Human Capital for candidates that would have responded to the advertisement of the position.
- ii. Conduct a shortlisting exercise, of at most ten (10) candidates for each position as per mandatory requirements on the job profile.
- iii. Be responsible for Curriculum Vitae (CV) ranking as part of the shortlisting process.
- iv. Provide a shortlisting report for all applications received in terms of clause 2.1 above. The report should provide a summary of candidates shortlisted and not shortlisted and the reasons in both cases.
- v. Design interview questions and rating sheets based on the job profiles.
- vi. Be responsible for contacting all selected candidates for them to attend the oral interviews.
