

- 8. Payment: 100% within 30 days of invoice date and receipt & acceptance of goods.

  - Company Profile
  - Proof of registration with PRAZ
  - A Valid NSSA Certificate
- **12.** Expected delivery period is 3 days from Purchase Order issue date. Bidders must state their delivery period and failure to deliver within the stated delivery timeline will result in cancellation of the Purchase Order and records will be kept and sent to the regulator (PRAZ).
